#### **HIGHWAY SUPERINTENDENT'S REPORT:**

**Equipment:** Repairs were done to the following trucks:

Truck #30 - replaced front spring package. Truck #16 - replaced rear spring hangers. Truck #3 replaced carrier bearing on drive shaft.

# **Summer Work:**

- The extreme hot weather could not have come at a better time, the Highway Garage was shut done last week. With the high temperatures, it was a good time for a break.
- We have finished the salt building foundation. Funding is still need to complete the building.
- The men have continued the roadside mowing on town and county roads, including the area next to the town park.
- The men have continued to cut and chip brush along Town roads.
- On Monday June 28<sup>th</sup>, we experienced a hard storm that closed portions of Tannery Road. due to the flooding, the department had to work for two days repairing wash outs and clearing debris from the road.
- On June 24<sup>th</sup>, the department used three trucks to haul stone for our road stone and oil projects.

<u>New Truck:</u> Our new tandem truck has arrived at Mohawk Valley Freightliner. It has continued its trip to Viking Cives in Harrisville for plow equipment. The single axle truck is due later in the summer.

<u>Tree Removal:</u> After some research H/S Stevens has discovered that Main Street (Westernville) is four rods or 66 feet wide. The tree that is between the road and the sidewalk in front of the Presbyterian Parsonage is in the Town's right of way. The removal of the tree is the Town's responsibility. A short discussion followed.

<u>10-98 Motion:</u> to authorize H/S Stevens to hire a tree service to remove the diseased tree in front of 9213 Main Street, Westernville. Cost not to exceed \$ 900.00.

<u>Dog Licenses:</u> Supervisor Davis stated that she had talked with NYS Agriculture & Markets concerning the new dog license regulations. In August or September there will be workshops (sponsored by the State) outlining the new rules and regulations. Starting January 2011, all licensing of dogs will be the responsibility of the townships.

<u>Summer Recreation Program:</u> C/M Murphy reported that there were eight responses to the help wanted ad placed in the Rome newspaper. She interviewed several of the individuals, but went with the original choices and hired Rachel Barbato and Kara Carr to be the program director and assistant. On July 05, 2010, the first trip was to the Ft. Rickey Game Farm with 15 children

attending between the ages of 8 years to 12 years. Supervisor Davis gave paperwork to C/M Murphy that came from Oneida County Personnel. This paperwork needs to be filled out and returned to Robin, or the director and assistant will not be paid.

**Salt Shed Grant:** Supervisor Davis is seeking the advice of several other individuals, that have done the paper work for grants from the State, in order to make sure that the grant paperwork is filled out correctly. She will have the paperwork done and submitted, to the State, by the July 31<sup>st</sup> dead line.

Article 78 Appeal: T/A Engelbrecht reported that the decision from the Judge has been

received. Judge Shaheen ruled in favor of the Town and the ZBA and they acted in a correct and proper manner, in dealing with the Croft appeal.

T/A Engelbrecht also stated that an intent to appeal Judge Shaheen's decision has been filed with Appellate Court by Mr. Pohopek. The intent is only a statement that he intends to appeal, but has nine months to actually file an appeal.

## **NEW BUSINESS:**

<u>Volunteer Dinner:</u> C/M Mader stated that the Board needs to plan the annual volunteer appreciation dinner. The tentative date is Thursday September 16, 2010. He will check the menu and prices at the Buffalo Head, Lake Delta Inn and Yaworski's and report back to the Board.
